# A Note from the Director

This past year marked another exciting chapter for the Kansas State University Finance Scholars Program. We remain committed to identifying high-potential students early and equipping them with the resources, training, and exposure needed to thrive in competitive finance careers. Our efforts are grounded in a commitment to excellence and the belief that Kansas State students can compete at the highest levels.

In 2024-2025, we hosted 18 industry speakers, including alumni and partners, expanded technical training with top firms like Training the Street and Financial Edge for developing modeling and valuation skills, and competed in five external competitions—highlighted by a first-place finish at Washington University's Olin School of Business Private Equity Challenge. These competitive settings continue to sharpen students' analytical, teamwork, and presentation abilities.

Our students traveled to eight cities, including visiting three new cities; Frankfurt, Zurich, and Miami, building industry knowledge and professional connections. Additionally, we launched two new initiatives: a Women in Finance Conference for high school students and an alumni-led mock interview Superday on campus where each participant completed three to four back-to-back interviews, simulating the structure and pressure of real-world recruiting days.

Student outcomes were outstanding—graduates secured roles at firms like Goldman Sachs and JP Morgan, and nearly all underclassmen landed summer internships. This success reflects the growing strength and reputation of the program. We welcomed an especially strong freshman cohort this year and continued our shift toward admitting students in their first or second year—a trend that positions them for even greater long-term success.

We are grateful to our alumni and supporters for their time, mentorship, and generosity. Whether it is hosting students for site visits, offering career advice, providing financial support, or returning to campus to teach and mentor, your involvement makes a real and lasting difference, and we are deeply grateful. Looking ahead, we are enhancing engagement options for alumni and supporters who want to contribute to the program's success, developing high school outreach plans and connecting with more alumni across the country.

IN THE SPRING, Scholars traveled to Miami, Chicago, and New York to focus on firms in asset management and investment banking. Alumni dinners were a highlight of the Chicago and New York trips and a Super Bowl gathering with Jeff Gates and Mike Moran was a great way to spend time during the Miami trip.

# 24-Hour Security Analysis Challenge

The third annual 24-Hour Security Analysis Challenge was held in the fall. Students participated in teams, each assigned to analyze VLTO, with a 24-hour window to make trade recommendations. Following the challenge, Jeff Gates conducted a workshop on campus to review the teams' findings and suggestions.







#### THREE BROTHERS. ONE WILDCAT LEGACY.

From their early days in Overland Park, Kansas, to leadership roles on Wall Street and beyond, Jordan, Austin, and Alex May represent a powerful legacy of excellence, resilience, and K-State pride. All three brothers are proud graduates of Kansas State University's finance program — and each credits the foundation laid in Manhattan as instrumental in shaping their careers in investment banking, commercial real estate, and corporate lending.

Jordan May, the eldest, is a
Director in CMBS Investments at
Prime Finance in New York, where
he has overseen \$1.5 billion in
investments and the management of
over 200 distressed loans. Named
one of CREFC's Top 20 Under 40,
Jordan reflects on the growth of
K-State's business school with pride:

"Watching Kansas State's business school and alumni base grow into what it has become today is something I'm incredibly proud of. From donors and mentors to top-tier faculty, it's rewarding to see the program thrive."

He cites Professor Eric Higgins as a formative influence:

"There was such a thing as a stupid question — and he'd let you know. But his deep expertise taught me how to think critically, which shaped how I invest today."

Austin May serves as a Director in Solomon Partners' Business Services

Group in Chicago, where he focuses on advising private equity-backed businesses in M&A transactions. His first day on campus remains one of his most vivid memories:

"That moment of stepping into life on my own — the anticipation of new experiences and independence was the beginning of my trajectory."

Austin credits the late Professor Scott Hendrix with helping open professional doors and guiding his early success:

"His dedication to students was unmatched. His guidance opened doors I didn't even know existed."

If given a do-over, he offers this advice to current students:

"Study abroad. If you have the chance, do it. It will challenge and change you in the best ways."

Alex May, the youngest, is Vice President of Lending & Capital Strategy at JPMorgan in Denver, where he leads the modeling and strategy for the global lending portfolio. Like his brothers, Alex forged lifelong memories in Manhattan — especially on Saturdays at Bill Snyder Family Stadium.

"There isn't much that beats a Saturday at the Bill. Cats by 50."

His most impactful professor?

His most impactful professor? Sabuhi Sardarli.

"He knew how to push students to take charge of their future. I still have nightmares about missing his final and having to stay an extra semester."



Alex's only regret? Not getting more involved while on campus:

"There's so much the business school offers. Mentorships, student groups, competitions — they all help position you for success."

When not closing deals, you can find the May brothers taking their competitive spirit to the slopes, courts, and trails. They share a passion for outdoor activities, travel, family, and constant learning — always seeking new perspectives and challenges.

Their journey — from Kansas classrooms to top-tier finance roles — continues to inspire current students, and is a powerful reminder of what's possible with hard work, humility, and a strong foundation.

"We all took different routes in finance, but it started with K-State. The education, the community, the opportunities — it all shaped who we are."

#### **EXPANDING ACCESS AND INSPIRATION: WOMEN IN FINANCE**

This year, we launched an exciting new initiative aimed at empowering the next generation of leaders—Women in Finance event for high school students. Designed to introduce young women to the dynamic world of finance, the event featured panel discussions, interactive workshops, and the opportunity to connect with successful professionals and current K-State Finance Scholars.

By showcasing real-world career paths and fostering early mentorship, this program reflects our commitment to broadening access, building confidence, and inspiring diverse talent to pursue opportunities in finance.



#### PREPARING FOR SUCCESS: SUPERDAY READINESS

This year, the Finance Scholars Program launched a new Superday readiness initiative to better prepare students for the demanding final-round interviews common in competitive finance recruiting. To support this effort, 18 alumni from across the country returned to campus to conduct mock interviews, offer personalized feedback, and share insights from their own experiences in investment banking, private equity, consulting, and more.

In addition to the professional preparation, the weekend also featured an alumni reunion, giving returning professionals a chance to reconnect with classmates and meet the next generation of K-State talent.

This initiative not only elevated students' readiness but also deepened the mentorship culture that sets our program apart—strengthening ties between past and present Finance Scholars.


